## CITY OF UNALASKA INSTRUCTIONS - BUSINESS LICENSE APPLICATION

For the privilege of engaging in business in the City of Unalaska, a business license is required.

This application may be used to purchase a <u>new</u> Business License or <u>renew</u> an existing Business License.

**Business License not required for:** nonprofit organizations (license fee waived for NPOs obtaining sales tax exemption certificates); investment clubs; state and federal government; and remote sellers with no physical presence in Unalaska that are registered with the Alaska Remote Seller Sales Tax Commission.

Business Licenses are not transferable. A new Business License is required for the following:

- A change in the business name
- A change in the line of business
- A change in the ownership of the business
- A change in business entity (for example, changing from a sole proprietorship to a corporation)
- A license that is expired for 2 years or more

**Business License Fee:** \$25 (new licenses and renewals)

Late Fees and Penalties: A person who fails to procure a business license or who fails to submit a timely application to renew a business license is assessed a late fee of \$10, plus a penalty of twenty-five (25%) of the license fee due for each thirty (30) day period of violation, or portion thereof, during which the person engages in business without a license. Additionally, you may be subject to a minor offense and the penalty as provided by UCO § 1.24.010, presently \$300.

**Application for Renewal:** Business licenses expire on December 31 each year. Applications to renew business licenses along with the applicable fee must be submitted to the City Clerk before 5:00 p.m. on December 31 each year. In the event December 31 falls on a weekend, the application to renew and the applicable fee will be considered timely if received before 5:00 p.m. on the first business day following December 31. Applications to renew and payment postmarked on December 31 are considered timely.

**Business Activity Code**: A business license issued to a person covers all of its operations in the City in that line of business, regardless of the number of its establishments. Please choose up to three codes from the following list to describe the business activity, with the first code listed being the primary line of business:
