**NEW STATE PUBLIC HEALTH DISASTER DECLARATION:** On November 6 Governor Dunleavy issued a new 30-day public health disaster declaration in response to the ongoing COVID-19 outbreak, effective for 30 days after the current declaration expires November 15. "This new disaster declaration is based upon the determination of moving from the threat of a pandemic to an actual pandemic. Given the tools the declaration will provide to the state, boroughs, and municipalities, as well as our health professionals and medical facilities, this declaration will continue to provide certainty to Alaskans during this pandemic," said Governor Mike Dunleavy. The Governor went on to say that the declaration ensures we remain in the best position to keep Alaskans safe and healthy, and allows local communities and health care providers maximum flexibility to respond to the virus.

**CITY COUNCIL MEETING TOMORROW:** The Unalaska City Council will consider a new declaration of local emergency and a continued mandate to protect the public health at their 6pm meeting on Tuesday, November 10.
