LOCAL RISK FACTOR: HIGH

LOCAL RISK FACTOR & CITY COUNCIL ACTION: Unalaska Unified Command raised the Local Risk Factor for COVID-19 back to "High" today because of new Community Acquired cases who had multiple close contacts in the community before receiving positive test for COVID-19. This information was reported to the Unalaska City Council last night at the beginning of a Special Meeting, which had called to consider reducing restrictions under the local COVID mandate. The City Council chose not to reduce restrictions based on the report of additional community cases of COVID-19. The local mandate adopted by Council at their February 9 meeting is in effect through noon on February 24, 2021.
