**COVID VACCINE ELIGIBILITY:** State DHSS announced yesterday that all individuals 16 years and above who live or work in Alaska are now eligible to receive the COVID-19 vaccine. If you are 16+ and have been waiting to get immunized, it's your turn! If you are 16 or 17 years old, you will need to make an appointment for the Pfizer vaccine. That is the only vaccine authorized by the U.S. Food and Drug Administration for that age group. Moderna and the Johnson & Johnson Janssen vaccines are authorized for individuals 18 years or older. Call the IFHS Clinic at 581-1202 or the Q-Tribe at 581-2920 to make your appointment.

**DMV TO RESUME ROAD TESTING IN MAY:** Starting May 14, 2021, the Unalaska DMV office will resume road tests each Friday. Call 581-2833 to schedule your appointment. COVID protocols will be observed.
