STATE OF ALASKA CASE COUNT: Reporting 775 new cases statewide, 13 new hospitalizations and 0 deaths since the April 26 news release.

On Monday, the State has reported one death associated with Unalaska/Aleutian West Census Area. This death occurred outside Alaska, but associated with Unalaska/Aleutian West Census Area based on how the State tracks COVID related deaths.
