### Coronavirus COVID-19

#### LOCAL RISK FACTOR: **High.**

**CITY OF UNALASKA COVID-19 CASE COUNT:** There are no confirmed cases of coronavirus in Unalaska, and no change from yesterday to our local testing numbers.

**STATE OF ALASKA COVID-19 CASE COUNT:** There are 235 confirmed cases in the state.

**PLANE CHARTER RESOURCES:** Governor Dunleavy's Mandate #12 prohibiting travel between communities in the state, except to support critical infrastructure or for critical personal needs, remains in effect. Also in effect is Mandate #10 requiring all persons arriving in the state to observe 14 days self-quarantine at their destination while monitoring for illness. If you must travel for allowed reasons, and because there is no commercial passenger service, we understand charters are available. The charter companies of which we are aware are listed below. The City of Unalaska makes no recommendation about these companies and has no agreements with them; we are simply providing information to the community.
