UNALASKA PUBLIC LIBRARY CURBSIDE CHECKOUT: Starting today, the Unalaska Public Library will offer curbside check-out service so patrons may check out materials while the library is closed to the public because of COVID-19 concerns. To search for available library materials, visit our catalog online at akuncl.us. You must wear a face covering when picking up items, and only one person may pick up items at a time. NO CONGREGATING NEAR THE LIBRARY: We understand the need to use the free Wi-Fi signal at the library because so many resources are only available online. To meet the need and to help folks maintain social distancing at the same time, the City "boosted" the Wi-Fi signal to cover more of the parking lot. Because we are now serving customers, if you are on foot or leave your vehicle, you must wear a face covering. People are not allowed to stand inside the closed walkway, which must remain clear; and remember to maintain at least six feet physical distance between you and other people at all times!
