LOCAL RISK FACTOR: High.

CITY OF UNALASKA COVID-19 CASE COUNT: There are 0 confirmed cases of coronavirus in Unalaska.

STATE OF ALASKA COVID-19 CASE COUNT: There are 337 confirmed cases in the state.

STATE MANDATES: Yesterday, Governor Dunleavy issued Health Mandate #16, with the "Reopening Alaska Responsibly Plan – Phase I-A". This mandate will go into effect at 8:00 a.m. on Friday, April 24 and is the first in a series of mandates intended to reopen Alaska businesses in a responsible manner. Mandate #16 addresses and modifies a number of prior Mandates and Health Care Advisories to implement Phase I of the Governor's plan to reopen businesses in the state. There are numerous attachments to the mandate which contain strict requirements and protocols that must be adhered to in order for a business to reopen. There are separate attachments for various categories of businesses.

- Attachment A: Essential Services and Critical Workforce Infrastructure
- Attachment D: Non-Essential Public Facing Businesses Generally (Not Including Retail) – modifies Mandate #11
- Attachment E: Retail Businesses – modifies Mandate #11
- Attachment F: Restaurants Dine-In Services – modifies Mandate #3.1
- Attachment G: Personal Care Services – modifies Mandate #11
- Attachment H: Non-Essential Non-Public-Facing Businesses – modifies Mandate #11
