Subject: Harvest Updates on Federal Water Groundfish Harvests, IFQ Sablefish, Halibut, and State Water Crab Harvest.

Federal Water Groundfish Harvest catch as of 10-2-21, IFQ Halibut, Sablefish and BSAI Crab, 10-11-21.

Fishing Seasons: The 2021 B season has now been open for 15 weeks of fishing. The harvest has been steadied all season long, and a big improvement over the 2020 Pollock B season. The 2021 season is 100,000MT ahead of last year's Pollock B harvest which is a full two weeks. About the only negative of this B season was the small size of Pollock that impacted fillet production. Last week saw a 9,000MT decrease in Pollock harvest to 7,313MT due to vessels having finished their Pollock allocations. The CV sector lead the way with a harvest of 7,313MT (16 million pounds). The total B season harvest is at 724,892MT in pounds (1.61 billion pounds)

The harvest by the Amendment 80 sector harvester last week decreased by 1,000MT 4,553MT for the week the seasonal harvest to 255,746MT (571 million pounds). The IFQ Halibut and Sablefish fisheries both had a good week with harvests of 600,000lbs. Halibut landed statewide season total is at 14.8 million pounds leaving 3.6 million pounds to harvest, 77% of the allocation has been taken. The CDQ harvest In Area 4-CDE (CDQ) 92landings for 678,452lbs leaving 350,948lbs to harvest 66% of the allocation has been harvested. Sablefish harvested 1.3 million pounds. Last week for the season 25.9 million pounds harvested, leaving 17.4 million pounds to harvest 60% of the allocation has been taken. Landings for Unalaska on Halibut and Sablefish species are still confidential until more buyers purchase fish.

Aleutian Island Golden King Crab fishery, opened on August 1, 2021. There have been 43 total landings. The Eastern District is at 36 landings for 2.3 million pounds the Western District is at 7 landing estimated at 600,000lbs. The total landings are at 43 for 2.9 million pounds the Golden King Crab allocation 5.9 million pounds leaving 2.9 million pounds to harvest.

The industry continues to work hard to reduce trawl bycatch of Salmon, Herring, and Black Cod during this B season, we are already seeing sight increases on the Sablefish, in the trawl fishery is at 157% taken -828MT over their cap amount. Chinook salmon is at 27% 12,442 fish and Herring is already at 69% with a bycatch 1,696MT. on a cap of 2,400MT. Chum salmon bycatch last week 2, fish the total 527,682 fish compared to 276,962 in 2020.

Overall Groundfish Harvest: The A season catch as of 10-2-2021 was 16,867MT (37 million pounds) with most of the harvest 7,313MT was Pollock. The season totals are 1,714,074MMT (3.82 billion pounds) harvested leaving 272,086MT (607million pounds) 86% of the overall annual harvest of 1.98MMT (4.4 billion pounds) has been harvested.

Pollock: The Pollock B season continues progressing well with some companies having completed their allocations, Alyeska Seafood's Westward and Unisea in Unalaska has finished, and is sending out people. I expect Northern Victor, Trident to follow soon. The Pollock harvest ending 10-2-21came in at 7,313MT (16 million pounds) that is 18,000MT decrease from the last few weeks harvest. Which is due to harvesters having finished their Pollock allocations and dropping out of the fishery. The Pollock harvest through October 2, 2021, 724,892MT of B season Pollock has been harvested (1.61 billion pounds) leaving 26,004MT (58 million pounds) to harvest, 97% of the B season Pollock is complete. The season may be done the week or so in late October. Of the 26,000MT to harvest 25,000MT is in the CV catcher vessel sector that delivers shoreside.

Inshore CV: this sector harvested 7,313MT last week, the seasonal harvest is 574,773MTthe B season allocation 330,165MT the B season harvest is at 314,954MT leaving 25,527MT of B season harvest, 95% of the B season has been taken and 99% of the annual allocation has been harvested.

At Sea Processors: At Sea sector harvested 0MT last week, the seasonal harvest is 479,890MT the B season allocation is 330,165 the harvest stands at 264,658MT leaving -525MT of the B season allocation to harvest 100% of the B season allocation has been taken and 100% of the seasonal allocation.

Mothership Sector: harvested last week was 0MT the seasonal harvest is at 120,002MT the B season total is at 66,593MT leaving -560MT of B season allocation to harvest 101% of the B season allocation has been harvested and 100% of the annual allocation has been harvested.

CDQ Sector: harvested last week was 0 MT the seasonal harvest is 139,330MT. The B season allocation is 76,803MT with 76,732MT having been harvested, leaving 70MT of the B season to harvest 100% of the B season allocation has been taken and 100% of the annual allocation.

Pollock Incidental Catch: last week harvest was 590MT for the season 34,885MT leaving 14,615MT to harvest 70% the annual allocation has been harvested.

Salmon bycatch: there was 12,442Chinook salmon taken as bycatch for the season, the 2021 Chinook bycatch allocation is at 27% leaving 33,258 fish of the cap amount of

45,000 fish. In 2020 23,770 fish were taken. In the other salmon category Chum salmon, we had no information on the catch of Chum salmon. The season total as of 10-2-21 is 527,692 fish this season in 2020 276,902 fish were taken.

Pacific Cod: Pacific Cod is still slow last week harvest through 10-2-21 was 1,798MT (4.0million pounds) the decrease from the previous weeks is due to the reduced effort by directed fishing completed in the Bering Sea. The major activity was in the CDQ trawl sector which harvested 1,015MT the rest of cod harvest is mostly from the trawl and freezer longline vessels. Boats. The total cod harvest by all sectors stands at 113,658MT (253 million pounds) leaving 19,010MT to harvest million pounds) 93% of the allocation has been harvested.

CV Pot/HL < 60'ft: harvested 0MT last week for the season 3,907MT leaving 37MT cod allocation to harvest, 99% of the seasonal allocation has been harvested

C/P Pot CPs harvested 26MT last week of B season Cod for the season 1,144MT. The B season remaining allocation is 523MT last week there was no harvest by this sector 69% of the seasonal allocation has been harvested.

Pot 60'>: harvested 0MT last week for the season 7,137MT leaving 2,197MT of A season allocation to harvest 71 % of the A/B season allocation has been harvested.

Hook and Line C/Ps: harvested 494MT last week for the season 50,139MT from the A/B season allocation of 4,472MT the A/B leaving 3,979MT to harvest 93% of the A/B season allocation has been harvested.

Pacific Cod CDQ: had a harvest 1,015MT last week for the season 8,402MT from an allocation of 13,395MT leaving 5,297MT 60% of the CDQ harvest has been taken.

Pacific Cod Trawl: this fishery will be opened on January 20,2021, with the A/B season allocation of 38,548MT the seasonal harvest for 3 sectors is CV (catcher vessels)20,004MT Amendment 80 8,366MT At Sea fleet 4,923MT. We had a harvest 262MT harvested last week with 235MT from the Amendment 80 sector, At Sea 0MT and CV sector 27MT A/B season harvest stands at 37,727MT which leaves 2,195MT of A/B/C season trawl cod to harvest 98% of the A/B/C season harvest has been taken.

Pacific Cod Jig: 0MT harvested last week, for the season 0MT harvested from the jig allocation of 665MT leaving 665MT 0% of the allocation has been harvested. NOAA reallocated 900MT of jig cod to 60'< pot cod vessels.

Amendment 80 Fisheries: The Amendment 80 sector for the week ending on October 2, 2021, fishing continues to be good last week, with fishing activity slow down with less vessels on the grounds in both the Bering Sea and in the Aleutian Islands. The total harvest stands 255,472MT (566 million pounds) of various species including the CDQ harvest. The harvest last week was 4,534MT (10 million pounds) the seasonal harvest totals by species are as follows, Yellowfin Sole 92,554MT, Rock Sole, 13,686MT Alaska

Plaice, 15,166MT, Flathead Sole 9,285MT, Arrowtooth Flounder 7,427MT, Kamchatka Flounder 6,477MT other Flatfish 2,420MT other species harvested this season including Perch and Rockfish, 34,516MT Atka Mackerel 50,235MT Octopus,152MT Skate 17,105MT Greenland Turbot, 1,581MT and Sablefish Trawl 2,868MT

IFQ Halibut/Sablefish 10-11-21

Halibut: through October 11, 2021. The Halibut allocation for Alaska is 18.56 million pounds. As of this morning 3,030 Halibut landings have been made for 14.8 million pounds. Leaving 3.6million pounds to harvest 80% of the allocation has been harvested. Last week saw a harvest of 600,000 by the fleet statewide. Ex-vessel prices have been in \$5.00-\$5.70 depending on size and port of landing. Homer is the leading port of landing at 2.8 million pounds, followed by Seward at 1.79 million pounds. Landings of Halibut have been made in Unalaska but are still confidential. In Area 4-CDE (CDQ) 92 landings for 679,452lbs leaving 350,948bs to harvest 66% of the allocation has been harvested.

Sablefish: through October11th ,2021, Sablefish allocation is set at 43.4 million pounds a 10-million-pound increase over last year allocation. As of this morning 1,653 landings have been made for 25.9million pounds leaving 17.4million pounds to harvest 60% of the allocation has been taken. Last week harvest saw a harvest of 1.3 million pounds. leading ports for Sablefish landings are Seward at 5.0 million pounds followed by Sitka at 3.9million pounds. Prices for Sablefish are in the \$2.00 to \$5.50 range depending on size. Landings of Sablefish in Unalaska are still confidential until more buyers purchase fish.

ADFG State Water Sablefish 10-11-21

The fishery is still ongoing, but fishing is very slow 5 vessels are registered to fish, the catch as of this morning is only 89,304lbs from 26 landing leaving 804,896lbs still to harvest 10% of the allocation has been taken. There were 4 landing made last week.

Unalaska Food and Bait Herring Fishery 10-11-21

The fishery is still open no one is currently fishing. The landings are confidential two seiners fished, possibly only 40% 3,000ST allocation was taken.

State Water Golden King Crab Fisheries 10-11-2021

Aleutian Island Golden King Crab fishery, opened on August 1, 2021. There have been 43 total landings. The Eastern District is at 36 landings for 2.3 million pounds the Western District is at 7 landing estimated at 600,000lbs. The total landings are at 43 for 2.9 million pounds the Golden King Crab allocation 5.9 million pounds leaving 2.9 million pounds to harvest.

State Water Dungeness Crab Fishery 10-11-21

The Dungeness Crab fishery has 6 vessels are registered to fish, with 40 landings for 1.026 million pounds. There is no poundage allocation on Dungeness Crab. ADFG has announced a closure for this fishery on October 18th, 2021, at noon.
