POSITION DUTIES AND RESPONSIBILITIES

- 1. Participates in the installation, maintenance, operation, and repair of wastewater collection, treatment and electrical systems.

- 4. Monitors gauges, meters, and control devices; interprets and records readings; observes variations in operating conditions and test results to determine processing requirements.

- Collects samples and performs standard wastewater treatment tests or analysis as necessary, and applies corrective measures to treatment processes.
- 7. Completes routine assignments and may be required to do work normally assigned to lower-level classifications.

- 9. Responds to customer service needs as directed and maintains good communication with the public, state officials, and co-workers.
