- Installs and repairs electrical transmission, distribution lines and feeders through the system. Performs necessary instrumentation and meter installation.
- Installs and repairs secondary feeders and service drops to electrical consumers.
- Inspects electrical systems and equipment to detect and correct faulty or worn out parts.
- Install and repair transformers, primary and secondary vaults, switching stations, section cans, and primary and secondary underground lines.
- Reads one-line diagrams, blueprints and schematics to repair and troubleshoot the distribution system.
- Measures, cuts bends, threads, assembles and install electrical conduit using such tools as hacksaws, pipe threaders, conduit benders and PCV heaters.
- Pulls conductors through conduit using recommended devices and utilizing proper safety practices.
- Performs cable splices and terminations on wire and cables up to 34,500 volts following manufacturers' recommendations.
- Test continuity of circuits to ensure electrical compatibility and safety of all components using standard instruments such as meggars, high-pots, multimeters, high voltage phasers, clamp on amp meters, rotation meters, and locators.
- Other duties and responsibilities as assigned.
