A RESOLUTION OF THE UNALASKA CITY COUNCIL AUTHORIZING THE CITY MANAGER TO SIGN AMENDMENT NO. 1 TO THE CITY HALL CBA BETWEEN THE CITY OF UNALASKA AND INTERNATIONAL UNION OF OPERATING ENGINEERS, LOCAL 302

WHEREAS, on May 28, 2019, the Unalaska City Council adopted Resolution 2019-28 approving a collective bargaining agreement ("City Hall CBA") between the City and the International Union of Operating Engineers, Local 302 ("IUOE") for city hall employees; and

WHEREAS, the City and IUOE agree there were errors in transcribing the final City Hall CBA prior to execution; and

WHEREAS, the City and IUOE desire that the City Hall CBA conform to the negotiated terms;


NOW, THEREFORE, IT IS HEREBY RESOLVED THAT THE UNALASKA CITY COUNCIL authorizes the City Manager to sign Amendment No. 1 to the City Hall CBA.

**AMENDMENT NO 1. TO
COLLECTIVE BARGAINING AGREEMENT
FOR CITY HALL EMPLOYEES
BETWEEN CITY OF UNALASKA AND IUOE 302**

WHEREAS, the City of Unalaska (“the City”) and the International Union of Operating Engineers, Local 302. (“302 IUOE”) have entered into the Collective Bargaining Agreement for city hall employees effective July 1, 2019 through June 30, 2022 (“City Hall CBA”); and

WHEREAS, the City and 302 IUOE agree there were errors in transcribing the final City Hall CBA prior to execution; and

WHEREAS, the City and 302 IUOE desire that the City Hall CBA conform to the negotiated terms;

NOW THEREFORE, the City of Unalaska and 302 IUOE hereby agree as follows:

1. **Amendment to Paragraph 16.2 Classifications and Wages.** Paragraph 16.2 of the City Hall CBA is amended by replacing the table of “Wages Effective July 1st, 2019 – June 20th, 2022” with the following table:


