City of Unalaska Legislative Report 4/26/21

This week has been mostly focused on the budget and the stimulus funding.

The Governor introduced **HB 181**, an Act making special appropriations relating to the American Rescue Plan Act (APRA) which was presented to House Finance by the Office of Management and Budget (OMB). Of the \$1.5B total ARPA funding, about \$1B is currently described as an unallocated general fund. OMB gave a high-level overview and outlined the Governors proposed categories that are essentially placeholders, stipulations from the US Department of Treasury are expected May 10th.

The House Finance committee has indicated its intent to roll much of the ARPA funds into the operating budget over the next week in order to streamline the decision-making to occur before the end of legislative session. Should the legislature not pass legislation to appropriate these incoming funds, the Governor would be left with the authority using the RPL process, a process which was criticized last year.

You should expect legislators to put their own stamp on the plans for this \$1.5 billion relief package — about one-third of which is already earmarked for specific programs. Here's how the governor's initial proposal aims to split up the money:

- There's \$150 million designated for revitalizing Alaska's tourism industry
- There's \$325 million set aside for aid to businesses and other organizations impacted by the pandemic, which would also go to "prepare Alaska's economy for investment" at the end of the pandemic
- Another \$325 million is designated for infrastructure investments in areas like broadband and water and sewer projects
- \$80 million would go toward emergency response, which the administration says would address economic impacts, the negative effects of domestic violence, food security and assistance to households and individual Alaskans
- About \$140 million would pay for existing government services and programs

Another \$450 million is already designated for specific purposes by the federal legislation. That includes \$230 million for payments to Alaska municipalities, most of which is already earmarked based on a federal formula.

The remaining \$220 million goes toward specific programs based on the ARPA, which includes:

- \$5 million for mental health treatment and grants
- \$28 million for childcare assistance for health care workers, emergency responders and other essential workers
- \$45 million for grants directly to qualified childcare providers
- \$24 million to help low-income Alaskans pay their heating bills
- \$22 million for COVID-19 testing and \$32 million for vaccinations, though each of these appropriations would be stretched out over several years
- \$7 million for grants for senior and disability programs like meal delivery and family caregivers
- \$6 million for upgrading Alaska's unemployment insurance computer system.
- \$6.5 million for transportation grants, which includes money for intercity buses.
- \$31 million for the University of Alaska. Half of the money must go toward grants to students, according to budget documents

Late afternoon on Friday, the House Finance Committee unveiled a draft proposal that calls for spending about \$700 million of the \$1 billion in ARPA funding and the remainder would be saved for spending next year. The proposal would send millions to nonprofits, local governments and tourism-related organizations. By substituting federal money for tax dollars in various places within the state budget, the plan frees about \$230 million for infrastructure spending and \$175 million for other uses, possibly use in a Permanent Fund dividend. The proposal if passed by the House will need approval of the Senate and Governor, who could veto elements. Some Senators would prefer to reserve about half of the \$1 billion for next year.

The House's plan includes the following:

\$454.5 million in federal aid would replace tax dollars in parts of the state budget. That frees \$230 million for the state's capital budget — used to fund construction and renovation projects — and \$175 million for the Permanent Fund dividend. This approach is needed because the federal money comes with rules that might preclude its use for things like the dividend. \$6 million for domestic violence shelters and similar organizations, which are suffering from federal budget cuts.\$30 million in grants to small businesses, similar to the AK CARES program that ended last year, \$80 million for local governments that have lost tax revenue because of the COVID-19 pandemic.\$30 million for nonprofit organizations, \$20 million for local economic development organizations to promote Alaska tourism.\$10 million for the Alaska Travel Industry Association.

The plan does not create any permanent new government programs, something requested by the House's Republican minority

SB 15, Open Meetings Act heard an overview of a committee substitute from Community & Regional Affairs (CRA). SB 15's full title: An Act relating to the Open Meetings Act; and establishing a civil penalty for violations of the open meeting requirements by members of governmental bodies. Amendments to arrive at this version changed SB 15, now it only applies to elected officials and invokes a 3-tier system, 1st infraction is a warning; 2nd is a civil penalty up to \$1K; and 3rd class B misdemeanor punishable by up to 90 days in jail and up to \$2K fine.

One testifier spoke in opposition and CSSB 15 moved out of committee.

HB 100, extending the Technical and Vocational Education Program (TVEP) beyond its "sunset" this year, was up April 16 in House Finance Committee. There is no Senate bill, so this must pass the House and get through the Senate by the May 19 adjournment. The bill would distribute \$11.5 million to 11 training providers including the University of Alaska. This bill is now in the Rules Committee waiting to be scheduled on the Floor.

HB 170, AIDEA would be authorized to participate in low-cost financing of green projects, an area conventional banks generally steer clear of because of lack of knowledge and track record, and the small size of most projects relative to perceived risks. The goal is for AIDEA to "derisk" projects and leverage financing by partnering with conventional financing, like the authority does now with its commercial loan participations with banks on real estate and other business lending. This bill passed out of the Energy Committee and is now up for two hearings this week, Monday and Friday for public testimony, in House Labor and Commerce.

SJR 13, related to improving broadband internet access passed out of Senate Community and Regional Affairs and will be brought up in Senate Labor and Commerce, Monday at 1:30pm.

HB 63, related to the Alaska Marine Highway Operation Board, with several amendments, moved out of State Affairs this week and be passed to the Rules Committee for Floor scheduling.
