<u>City of Unalaska Legislative Report</u> <u>3/12/21</u>

Things seem very busy, but overall movement of legislation has been slow. At this point finance subcommittees are still ongoing in both bodies. With the capitol closed to the public it is difficult to know if things are more productive inside than they appear from afar.

After being asked to leave the House Health and Social Committee hearing and the Senate floor session for not wearing appropriate face protection, on Wednesday the Senate voted to allow its leaders to exclude Senator Reinbold from meetings should she not abide by COVID-19 policies in place. Senate President Micciche advised the media that same day that there were 26 legislators and staff either positive with COVID-19 or in quarantine, including one staff who has been hospitalized due to COVID complications. Personnel matters seem to be taking up a large amount of time over the last several weeks.

In an unorthodox scheduling move, both the Senate and House Finance committees have scheduled lengthy hearings the budget bills next week. This step in the process does not typically occur until after finance subcommittee closeouts have taken place. The Senate has noticed public testimony as follows:

Public testimony has not been noticed for these hearings.

The Department of Administration is currently advancing a plan to privatize Division of Motor Vehicles offices in Eagle River, Homer, Tok, Valdez, Delta Junction, and Haines, which would likely result in price hikes on Alaskans. In response, legislators announced they will be introducing a bill aimed at preventing negative consequences for Alaskans in each of the communities facing potential impacts, which likely means those closures would not be happening.

Senate Concurrent Resolution 1, which would suspend uniform rules for legislative business and allow voting by videoconference was moved to House Rules last week where it awaits House Floor scheduling. The resolution passed the Senate 19-0 on February 3rd and was given two committees of referral by the House. There are some that see the resolution as an important way to conduct legislative business during the pandemic, however others see virtual business as inefficient and a deterrent to finishing business.

HB76 The house version of a disaster relief extension bill, passed House Health and Social Services on March 9th, adopting a committee substitute to include a title change, new language regarding "informed consent" and "personal objections;" and makes changes to legislative findings and civil liability. On March 11th, House HSS Co-chairs, Representatives Zulkosky and Snyder presented the CS to House Finance Committee chaired by Representative Merrick, and **public testimony is noticed for March 15th at 1:30pm.** While SB56, the senate's version of the disaster relief bill, has not had any action since February 15th, the bill remains in Senate Finance and could be taken up at any time under "bills previously heard".

HB 45 Workers Compensation and Contagious Diseases bill was heard last Friday and is scheduled for **public testimony on March 15th at 6:30pm in House Labor and Commerce.** If enacted, an individual in one of the defined occupations who works directly with the public within two weeks of a positive test or diagnosis of a disease would be assumed to have contracted the infection at work and would be covered by workers' compensation. An employer could only rebut a claim by producing clear and convincing evidence that an employee infection was not work related. This would only apply in the event of a disaster emergency declared due to a contagious disease outbreak.

SB15 Penalties for opens meetings act violations passed Senate Community and Regional Affairs on March 9th. A committee substitute was adopted that clarified the role of the Alaska Public Offices Commission (APOC) as the enforcement entity, adopted a fine of \$1000 for violations, and clarified the definitions of "knowingly" and "public official". The bill is now in Senate Judiciary and scheduled for a hearing on March 17th at 1:30 p.m.

SB24 Authorizing virtual meetings for corporations, which includes nonprofits, was heard and held on March 10th in House Labor and Commerce and is scheduled for another hearing on Friday at 3:15 PM in the same committee. This fast-moving bill passed the Senate last week.

SB 74 THE GO Bonds State Infrastructure Projects was heard again by Senate Transportation on Tuesday. Sen. Micciche questioned if the intent is to use as matching funds, was that best use of the GO bonds. The answer from the OMB Director was, if you can use bond funding to get match monies then you get the benefit of both worlds. There was much dialog about how these projects were identified and Sen. Kiehl's legal questions raised last week. Bill Milks, Assistant Attorney General, basically identified the language in the constitution but admitted that it was a grey area. The question related to legality of this bill continues to be unanswered or unclear.
