City of Unalaska Legislative Report 2/26/21

It has been a busy week, although not much was accomplished when it comes to legislation.

As you likely know from all news media outlets, the Governor has tested positive for COVID-19 and is currently quarantining at his home in the Matanuska Valley. Also, a Representative in the House tested positive on Wednesday, resulting in all House committee meetings being canceled, and closure of the Capitol to all Representatives and staff for the remainder of the week. With the delayed organization of the House this will certainly impact any plans for early adjournment.

The closure delayed the finance subcommittee work even further, which normally would be near completion at this point. The standing finance committees cannot start actively working on the budget until the subcommittees have completed their work and submitted recommendations. We can only hope that an outbreak does not occur next week causing further delays.

Early this week House Finance heard an overview from the Alaska Permanent Fund Corporation, and a presentation by Office of Management & Budget (OMB) director Neil Steininger. Meanwhile Senate Finance discussed school maintenance, deferred highway maintenance, and the Alaska Mental Health Trust Authority. Senate Finance heard the governor's budget amendments last week.

There are several hearings scheduled next week, however uncertainty around COVID-19 exposure remains a concern. The Senate finance subcommittees continue to progress with the House still having difficulty with forward movement.

After SB56, disaster relief, fell short in the Senate in recent weeks, HB71, a house version appeared to initially be on a fast track and expected to include a very limited number of measures. Limiting the number may be proving too challenging, as HB71 was waived through House HSS last week and noticed for House Finance, but now the bill is noticed for House HSS on Tuesday and Thursday, signaling it may be back at the starting point. The future of both SB56 and HB71 is unknown.

SB15, penalties for opens meetings act violations was heard and held in Senate Community and Regional Affairs on Thursday, February 25th. Senator Hughes asked whether the intent of the bill was to apply to community councils which have informal procedures. It was confirmed this was the intent. Senator Gray-Jackson asked how this would interface with the Municipality of Anchorage which has its own code of ethics and commission. The answer to this question was not immediately known, however it will be read into the record when the answer is known. After review of the sectional, the bill was set aside.

The Governor's Chief of Staff, Ben Stevens, is leaving the Administration to take a position with ConocoPhillips as vice president of external affairs and transportation. Randy Ruaro, who recently took a

Deputy Chief of Staff position in the Governor's office, will become acting Chief of Staff pending a permanent appointment.

The governor's administration announced it is appealing the lawsuit that invalidated his appointments to the Alaska Supreme Court.
