## <u>City of Unalaska Legislative Report</u> <u>3/20/21</u>

Friday marked day 60 of the legislative session, which would mark the constitutional halfway point for the legislative session, but if there is an obvious indication it is that things are expected to run long, potentially very long.

The theatrics related to Covid-19 mandates continue to cause delays. Friday Representative Kurka brought the House floor session to a standstill amid a dispute over his "Government mandated muzzle" mask, which was a violation of the Legislature's requirements for professional attire on the floor. Earlier this week, Kurka left the House floor rather than wear a mask. As a result, the House, which had been set to take up a Senate bill allowing remote meetings for some boards and corporations was adjourned without action until Saturday.

On the budget front, the state did get some good news this week with a revised spring revenue forecast which projects \$460 million of revenue available for the next budget cycle. While this lifts some burden, there still remains a sizable fiscal gap to meet the governor's proposals for the budget and dividends. With \$1.25B in federal relief funds pending, legislators are expected to focus on opportunities to replace UGF with federal funds to reduce the need to draw from the permanent fund Earning Reserves Account (ERA). A major question which remains to be answered is the timing of the federal treasuring and to what extent the legislature might engage in that decision making process. The last round of federal funding was received outside legislative session and was allocated by the governor using an RPL process which has been criticized. The House announced an anticipated time line for completing session to be mid-May, and whether their work includes the federal aid is unknown. In the long term, the positive spring forecast coupled with incoming federal dollars once again looks to delay difficult revenue discussions to future legislatures, with next year being an election year.

There was much conversation surrounding the recently approved federal American Rescue Plan Act which will potentially infuse over a billion dollars into the fiscal mix. There may be additional funding from that for agencies to utilize or distribute. Essentially, the ARP may make the State whole for this year but is definitely not a long term solution toward a sustainable budget.

On Wednesday and Thursday, March 17th and 18th, the Senate Finance Committee took public testimony during four separate listening sessions on SB49 Operating Budget, SB50 Capital Budget, and SB51 Mental Health Budget. A total of 93 Alaskans provided testimony.

House Finance Committee co-Chair Rep. Neal Foster announced public testimony is tentatively scheduled for April 1-3<sup>rd</sup>. House finance subcommittees are on a fast track with substantive hearings and closeouts across subcommittees in the next week.

HB 76, A bill related to extension of the emergency disaster declaration was amended and passed out of the House Health and Social Services Committee this week after it received public testimony. While several testified that the declaration is not needed, there may still be some unknown issues that may have unintended consequences as brought forward by many associations including; the Alaska State Chamber of Commerce, Alaska Public Health Association, Food Bank of Alaska, the Alaska Municipal League, ASHNHA, The Alaska Children's Trust, the Alaska Food Coalition, the Alaska Public Health Association.

Meanwhile in the Senate, **SB56** (Senate version of HB 76) – after no action since the declaration expired on February 2022- the Senate Finance Committee has noticed a hearing for its version, on Wednesday March  $24^{\text{th}}$ .

**HB 45**, Related to workers compensation coverage of contagious diseases passed out of House Labor and Commerce moving to the next committee of referral, House Finance.

**SB 74**, The Governors General Obligation Bonds bill was heard in the Senate Transportation Committee, there were many amendments related to the list of projects and discussion about the procedural issues surrounding SB74. The bill was eventually held and will be taken up again on Tuesday, March 23<sup>rd</sup>.

**SB15,** by Senator Costello, penalties for opens meetings act violations was heard briefly in Senate Judiciary this week and scheduled for a hearing on March 22nd. It is not clear at this time whether public testimony will be taken. If SB 15 becomes law, anyone could file a complaint with the Alaska Public Offices Commission, alleging that a public official had violated the States Open meetings Act. The commission is required to investigate the complaint and if commissioners agree that the compliant is valid, the official could be fined up to \$1000.00.

**HB63**, relating to renaming the Alaska Marine Transportation Advisory Board to an operational board that has ability to assess and suggest marine business practices that enhance revenues and reduce costs passed out of House Transportation and now moves to House Finance.
