## City of Unalaska Legislative Report 3/26/21

Overall a somewhat slow week in Juneau, outside finance subcommittee meetings and close outs, there was a fair amount of time spent on bills related to extending the Governor's emergency disaster declaration, which now the Administration indicates they really do not need.

Lawmakers learned this week that Alaska's share of the \$1.9 trillion American Rescue Plan Act (ARP) could send about \$1.2 billion to the state, plus \$200 million more for housing aid, almost \$360 million for education and \$240 million directly to communities. It appears this discovery has led to a reduced sense of urgency with some Legislators to complete the budget process in a timely manner.

The federal aid does not all have to be spent this year, we are still waiting on more details on the spending rules and how the funds may be used to back-fill budget deficits.

Representative Spohnholz introduced a bill that would implement a spending cap, the proposal would set a cap based on an average of state spending over the past three years with allowances for inflation and population growth. Excluded from the proposed cap would be the PFD, school bond debit reimbursement and spending for emergencies, the bill is **HB141**. The Governor and Senator von Imhof also have introduced spending cap legislation.

**HB 76**, relating to the extension of the emergency disaster was amended, stripped down and passed out of the House, now heads to the Senate.

Both **HB 76** and **SB 56** are noticed for hearings in Senate Finance Monday at 1PM, and **HB 76** is notice for Tuesday at 9AM signaling the house version may be the intended vehicle.

SB 24, allowing virtual meetings passed both bodies and is awaiting transmittal to the Governor.

**SB74**, related to the GO Bonds was heard and passed out of Senate Transportation this week. Although, many are skeptical that this bill will progress. Alaska is in its 9th consecutive year of deficit spending, and a 10th is expected next year. Borrowing \$354 million would cost about \$93 million in net interest, according to Department of Revenue. Some Senators have stated we are in a different position financially than when the package was assembled, while others believe it is problematic to borrow when "we are already in the hole". They are considering the federal stimulus monies to replace the GO Bond idea. The Federal Government has not yet clarified what those funds can actually be spent on.

Under the amended bill that was passed out of Senate Transportation, the state would borrow \$303 million, and the list of projects has changed to exclude airports, which have already received a large amount of federal aid and other projects that are already under contract or are not shovel ready.

The House version of the GO Bonds bill, **HB93**, is on the schedule to be heard in House Finance on Monday, March 30<sup>th</sup> at 1:30PM.

AMHS, largely due to CARES Act funding, 2022 is expected to have total revenues of 7.3 percent more than 2021. That is with a 16 percent decrease in port calls. The Senate Finance committee asked DOT to look at a hypothetical scenario with more service.

DOT, Deputy Commissioner, Rob Carpenter articulated that the goal for each year has been that AMHS funding sources would be 50 percent General Fund and 50 percent fare and freight revenue. It wasn't clear if that was achievable for 2022.

Also discussed was the Tustemena Replacement fund. This project is in the DOT/PF State Transportation Infrastructure Plan (STIP) and is in the final design phase with about 65-70% completed. It is slated for construction in 2022. The Department is still working with the Federal Delegation for financing options.
