## City of Unalaska Legislative Report 4/11/21

It is the second week of April and it is painfully obvious that we will be in Juneau until, at the very least, mid-May. No matter what side of the aisle you are, most folks believe that the overall budget will likely be a status quo from last year, not a lot of cuts and not a lot of addons. The House is tentatively scheduled to vote on the budget during the week of April 19, and after that, it would advance to the Senate.

While things are moving at a reduced pace this week, there is still a great deal of work left in order to pass a budget that properly funds essential state services. Now, a large part of that equation is the federal stimulus dollars the state is set to receive from the federal government next month. As the appropriating body, the legislature must decide how to best allocate those funds.

At this point the funding guidelines have not been defined and likely won't be understood or decided within the timeline of a 121 session, and the Legislature doesn't want to adjourn and leave Juneau with the governor having the autonomy to make those decisions.

**HB 76** regarding extending the COVID-19 disaster emergency was scheduled to be taken up in Senate Finance on Tuesday, was later removed and not heard. It is rescheduled for Monday the 12<sup>th</sup>. Likely we will see a "watered down" version of the original bill.

HB 30, which addresses workers compensation, death and partial impairment, passed out of the House Labor & Commerce committee this week with five "do pass" and one no recommendation. The next committee of referral is Finance. There continues to be concern with this bill, specifically, section 4 of the bill which moves responsibility to an employer, who's employee dies on the job, to provide notification of the worker's death to the worker's estate personal representative, extending the death benefits to the worker's dependents through age 23 which is a significant jump from the current age of 19, creating a significant increase in liability and premium costs. Also, section 2 of the bill increases the employee's whole-body valuation, paid in the event of permanent disability or death, all of these changes particularly at once could be rather costly to employers.

CSSB 17, relating to energy efficiency and policy in public building was heard in Senate Community and Regional Affairs this week. Sen. Begich recapped the intention of the which bill does two things. Takes a 2010 bill, that had two major factors, regarding setting policy around clean energy and setting policy around retrofitting buildings. This bill lowers the threshold from 10K sf to 5K sf and includes other buildings in the mix such as schools that are perhaps larger but part of PCE and aligning current terminology for clean energy. The bill passed out of committee with "do pass" Gray-Jackson; no recommendation, Hughes, Myers. The next committee of referral is Senate Labor and Commerce.

There have been dueling meetings this week on the legislation related to the Alaska Marine Highway(AMHS) operations board make-up. **HB 63** by Speaker Stutes was heard for the second time in House State Affairs, looks like there will be amendments taken up, particularly to an earlier effective date.

**SB 103**, the Governor's version of the AMHS Operation and Planning Board under-went several amendments in Senate Transportation this week, primarily related to board appointment and separation of powers issues. One thing for sure is both bodies are looking to get politics out of the equation and create a board that will look for sustainable long-term planning and fiscal structure.
