<u>City of Unalaska Legislative Report</u> <u>4/30/21</u>

The House operating budget has been in the spotlight this week with the House Finance Committee going well into Thursday evening to get through the many amendments and passed HB69 out of committee. The amended budget proposal rolls all the different types of funding into a single budget bill <u>HB 69</u>. The House version of the FY22 budget includes many Community priorities including full funding for school bond debt reimbursement and Community Assistance

The House took up the bill on the Floor late Friday afternoon with amendments due by noon on Saturday, they will work over the weekend to pass **HB69**. It is scheduled, pending referral, in Senate Finance early next week. Update: The House finally adjourned late on Saturday and will be back on the floor Sunday at 11am, in third reading.

We are about three weeks from the constitutional adjournment date and the focus will be on the operating and capital budgets, we will see most other legislation stall until next year and committees will begin to shut down. Floor debates will be long and laborious.

Legislative updates from here forward will primarily focus on the schedule and changes to the budget. With fast paced legislation I will provide email updates.

HB76, the disaster declaration extension passed both bodies this week, after months of discussion and a looming deadline. Referred to as "disaster declaration lite" the bill enacted minimal measures needed to keep the vaccines flowing and to qualify for federal aid. Gov. Dunleavy signed the bill on Friday and then promptly ended the disaster declaration, which immediately terminated several healthcare provisions in the bill, including expedited licensing, telemedicine flexibilities, and liability protection.
