## City of Unalaska Legislative Report 4/4/21

A number of bills were heard this week but movement on major legislation is moving pretty slow. Many meetings were held to conclude required reviews of the Governor's appointments to various state boards and commissions, but still no word on when the joint session to confirm appointments will take place.

The issue that is garnering much attention is the pending receipt of the \$2 billion in federal funds for Alaska, courtesy of the American Recovery Protection Act (ARP). This does not include President Biden's proposed federal infrastructure program, which Congress has yet to approve. The APR monies has yet to be delivered and the Legislature must pass an appropriations bill as well as authority for state agencies to receive the funds. That means things will get very busy in the capitol next month, as the Legislature's required adjournment approaches.

Senate Finance heard from economist, Dr. Guttabi, last week and he began by saying Alaska economy is weak, February 2021 employment was down 22,000 jobs from last year, almost all private sector, as Alaska government has experienced little in losses. The unusual element of the statistics was that while jobs were down, personal income is significantly up due to federal stimulus monies. Gross domestic product decreased by \$2.6 billion but personal income was up \$1.4 billion, a remarkable situation.

Senate Finance also took up <u>HB76</u>, extending the disaster declaration – some version of that bill is expected of that to move forward next week, potentially, in order to meet the limited authority needs of the Governor. Senate President Micciche indicated that the end result would likely more closely resemble what the Governor is asking for now, rather than start with their own bill this late in the session.

The two pieces of legislation related to the selection, authority and makeup of the AMHS advisory group/board, one being proposed by the Governor and the other Speaker Stutes, appear had hearings this week and are on the schedule to be taken up next week. There seems to be some interest in getting some reform version passed this year.

House Finance will take public testimony on the Senate version of the operating budget next week on Thursday, Friday and Saturday. Due to many changes each day please use the link below the scheduled meetings section to determine when testimony for your location is scheduled.

**HB 93**, the Governor's GO Bonds bill was heard in House Finance this week, of note was the testimony from Marie Marx with Legislative Legal regarding the legal difficulties of the bill. She noted three possible areas that could be challenged if the bill were to be passed, the single subject clause requiring all items fit one single issue, the definition of capital improvements as structures and project specificity.

**AMHS**, largely due to CARES Act funding, 2022 is expected to have total revenues of 7.3 percent more than 2021. That is with a 16 percent decrease in port calls. The Senate Finance committee asked DOT to look at a hypothetical scenario with more service.

DOT, Deputy Commissioner, Rob Carpenter articulated that the goal for each year has been that AMHS funding sources would be 50 percent General Fund and 50 percent fare and freight revenue. It wasn't clear if that was achievable for 2022.

Also discussed was the Tustemena Replacement fund. This project is in the DOT/PF State Transportation Infrastructure Plan (STIP) and is in the final design phase with about 65-70% completed. It is slated for construction in 2022. The Department is still working with the Federal Delegation for financing options.
