Technical and Price Proposals will be accepted before and on the published date and until the time specified. It is the Respondent's sole and independent responsibility to submit their proposals in a timely manner. Respondents assume the risk of delays in delivery of email; delay or interruption of transmissions; or technical difficulties such as software incompatibility. Note that internet service to Unalaska is regularly delayed due to slow connection speed and foul weather. The City of Unalaska may, at its sole discretion, relax or extend the submission deadline if deemed necessary in the interest of just and fair administration of the Project.
