### **ITEM 1**

Contract: *City of Unalaska Lake & River Restoration Projects*

Section: *00100 Bidders Instructions & Bidder Question #16 (Addendum No. 2)*

Replace the response to Bidder Question #16 (Addendum #2) and Item I under 16 "Award of Contract" with:

Grant funded additive alternates have been prioritized numerically with Additive Alternate #1 being the first to be selected, and Additive Alternate #5 being the last. The Base bid and additive alternates will be awarded as funding allows in the order of priority as identified. However, if the next priority item would cause the overall project to be over budget or cannot be awarded for other reasons, an item of lower priority can be substituted. Additionally, non-grant funded additive alternates can be awarded with any combination of the awarded grant funded additive alternates. The basis for award will be lowest bid price for the Base Bid plus all the Additive Alternates selected for award.

**ITEM 2**

Contract: *City of Unalaska Lake & River Restoration Projects*

Section: *00100 Bidders Instructions & Bidder section 13 "Modifications and Withdrawals of Bids."*

Replace Item A with:

Prior to the time and date designated for receipt of Bids, any Bid submitted may be withdrawn by notice to the party receiving Bids at the place designated for receipt of Bids. Such notice shall be in writing over the signature of the Bidder or by facsimile. If by facsimile, the modification received shall be over the signature of the Bidder and shall be received before the date and time set for receipt of Bids.
