Question 1: Is it possible to arrange a Site Visit?

Question 2: Will the City of Unalaska pay for permitting fees, if any?

Response 2: Yes.

- Question 3: Is this project exempt from the 3% sales tax?
- **Response 3:** No. However, the contractor can submit a request for refund of sales tax. Sales tax refund information and application can be found on the City website under the Commerce heading.
- **Question 4:** Is there a local courier service in Unalaska? We want to Pen-Pak our Bid, and so far we're unable to locate someone to deliver it.
- **Response 4:** There is not a local courier service in Unalaska.
- Question 5: Can we submit bids electronically via email?
- **Response 5:** Yes. Bids may be submitted electronically via email. If emailed, they must be sent to both of the following individuals:

- Question 6: Will Bid Modifications Add / Deducts, be acceptable via Fax?
- **Response 6:** No bid mods (Add or Deduct) will be accepted at any time.
- Question 7: Is housing available during the construction timeframe?
- **Response 7:** The recommendation for housing options: Grand Aleutian Hotel 866-581-3844. A construction man-camp is not allowed on the project sites.
- Question 8: As this is a City project, will dump fees still apply?
- **Response 8:** The City will waive dump fees but loads will still be weighed on scale at landfill.
- Question 9: Is this a lump sum bid for the three projects identified in the RFQ?
- **Response 9:** Using the revised Bid Form, please submit three lump sum price quotes, one for each of the three flooring projects identified in the RFQ. AND, provide unit prices for labor, travel costs, and per diem on the Revised Bid Form.

Question 10: Does this work fall under the ADOL requirements?

Response 10: Yes. All provisions of ADOL apply. The ADOL threshold is \$25,000. Any government construction project over the \$25,000 threshold is required to comply with ADOL. Refer to the publication, *Pamphlet 400, Title 36, Public Contracts*.
