## **BUSINESS ITEMS:**

1. **CERTIFICATION**: OCTOBER 2, 2007 MUNICIPAL ELECTION.

Mayor Marquardt explained that the election investigation was completed on Friday; conclusion of report was that all of the persons that voted in the 2007 municipal election were on the voter registration rolls. They belonged on the voter registration rolls and were qualified to vote. The challenge is not sustained. The election results are valid and must be certified. 3. **RESOLUTION NO. 2007-52**: APPOINTING JUDGES AND CLERKS FOR THE RUN-OFF ELECTION ON NOVEMBER 5, 2007 AND JUDGES TO SERVE ON THE CANVASS COMMITTEE.

Flanagan move to adopt Resolution NO. 2007-52, McGlashan second.

DISCUSSION: Mayor Marquardt read off the names of the judges and clerks.

VOTE: UNANIMOUS
