1. ORDINANCE 2011-07 FIRST READING: AMENDING UNALASKA CODE OF ORDINANCES SECTION 10.08.022(A) TO DESIGNATE SERVICES ALLOWED TO UTILIZE SHUNT TYPE DISCONNECTS, AND SECTION 10.08.022(H) TO DESIGNATE THAT THE COST OF LABOR FOR NEW INSTALLATIONS NECESSARY DUE TO LOAD CHANGE REQUIREMENTS WILL BE BORNE BY THE CONSUMER, AND SECTIONS 10.08.024(G) TO ALLOW FOR ESTIMATING USAGE UPON ELECTRIC METER MALFUNCTION, AND 10.12.020(A)(3) TO ALLOW FOR ESTIMATING USAGE UPON WATER METER MALFUNCTION

Peck made a motion to adopt Ordinance 2011-07 and move it to Public Hearing and Second Reading on August 9, 2011; McGlashan seconded.

Peck made a motion to amend Ordinance 2011-07 by striking the added sentence at the end of the first paragraph in (H) Load Changes that states, "The consumer shall submit a new Utility Service Request for service upgrades and shall bear the cost of labor and equipment required for the installation of all secondary electrical equipment upgrades"; Gregory seconded.

VOTE: Yes – 1; No – 4 Motion failed.

Peck made a motion to amend Ordinance 2011-07 to state that all primary line extension costs will be borne by the utility. Motion died for lack of a second.

VOTE on MAIN MOTION: Yes - 3; No - 2 Motion failed
