4. **RESOLUTION 2012-49**: DEFINING THE CITY'S POLICY ON PARTICIPATION IN FUNDING OF ELECTRIC UTILITY EXTENSION COSTS FOR PRIMARY LINE EXTENSIONS

Rowland made a motion to approve Resolution 2012-49; Gregory seconded.

Roger Deffendall offered public comment on Resolution 2012-49.

Johnson made a motion to postpone consideration of Resolution 2012-49 to the July 24th meeting to include participation in funding of the electric utility extension costs for primary and secondary lines for industrial, large general and small general, and residential; Rowland seconded.

The City Manager asked for clarification. Mayor Marquardt asked for a show of hands by Council members on who would like to consider participation in funding of electric utility extension costs for primary and secondary lines to residential only and primary lines for industrial, large general, and small general. Four of five Council members indicated they agreed with Mayor Marquardt's summary of what they would like to consider.

With Johnson's permission, Mayor Marquardt restated the motion as a motion to postpone consideration of Resolution 2012-49 to the July 24th meeting.

VOTE to Postpone: Passed Unanimously

5. **RESOLUTION 2012-50**: DEFINING THE CITY'S POLICY ON PARTICIPATION IN FUNDING OF SEWER AND WATER UTILITY EXTENSION COSTS FOR PRIMARY LINE EXTENSIONS
