PLEDGE OF ALLEGIANCE: Mayor Marquardt led the Pledge of Allegiance

RECOGNITION OF VISITORS: Evan Rose of Alaska Permanent Capital Management and Dempsey Thieman, Vice President and Senior Engineer with PN&D, were introduced.

APPROVAL OF AGENDA: The agenda was adopted with no changes.

MINUTES: The minutes of July 24, 2012 were approved as submitted.

BOARD/COMMISSION REPORTS: Planning Commission minutes were included in the packet.

AWARDS/PRESENTATIONS: Mayor Marquardt administered the oath of office to two new police officers, Sean Perry and Charles Lee.

Chris Bobbitt, member of the Planning Commission, spoke about the process the commission went through as it considered the recommended changes to the ordinance.

Robinson made a motion to amend the ordinance by deleting all changes to §8.08.100; Gregory seconded.

VOTE on AMENDMENT: Motion Passed Unanimously by Roll Call Vote.

Robinson made a motion to make setbacks uniform. Motion died for lack of a second.

VOTE on MAIN MOTION: Motion Passed Unanimously by Roll Call Vote.

4. RESOLUTION 2012-61: AWARDING A CONTRACT FOR AN EMPLOYEE COMPENSATION AND CLASSIFICATION STUDY TO FOX LAWSON AND ASSOCIATES
