Johnson made a motion to approve Resolution 2013-20; Gregory seconded.

VOTE: Motion Passed Unanimously.

2. RESOLUTION 2013-13: ADOPTING FY14 BUDGET GOALS

Johnson made a motion to approve Resolution 2013-13; Gregory seconded.

VOTE: Motion Passed Unanimously.

3. MAYOR TRAVEL: MANAGING OUR NATION'S FISHERIES NATIONAL CONFERENCE, WASHINGTON, DC, MAY 7 – 9, 2013

Enlow made a motion to approve travel to Washington, DC for the Managing Our Nation's Fisheries Conference from May 7 to May 9 of 2013; Johnson seconded.

Robinson asked that not only social and economic impacts be kept in mind, but that environmental impacts be considered as well. To that end, he asked that the message be carried that environmental clean-up should be tied to quotas.

UNALASKA CITY COUNCIL Minutes March 12, 2013

Enlow spoke to the importance of the conference.

Johnson made a motion to amend the main motion to send Mayor Marquardt to the conference; Enlow seconded.

Robinson also asked that the importance of sustainability of the fishery and of the subsistence lifestyle be kept in mind by those involved in the conference.

VOTE on Amendment: Motion Passed Unanimously.

VOTE on Main Motion as Amended: Motion Passed Unanimously.

COUNCIL DIRECTIVES

Robinson made a motion to direct the City Manager to make a change to the ordinance on 5th wheels to allow for 5th wheels to be operated in the raised position when running with empty chassis; Gregory seconded.

Skip Southworth, crane operator, spoke in favor of the directive. He asked that the ordinance also be revised to state that 5th wheels can be up whenever the vehicle is on dirt road.

Robinson revised his motion to direct the City Manager to bring back to Council options for allowing 5th wheels with empty chassis to be allowed to be in the raised position; Gregory seconded.

VOTE: Yes - 3; No - 1. Motion Failed.
