- 1. Frank Kelty asked the City to consider painting the leachate tank with words or a logo identifying Unalaska. He suggested that "City of Unalaska" or "Unalaska" be painted on the side and on the top.
- 2. Frank Kelty also asked if there is anything that can be done about cleaning up residential properties that are cluttered and/or unsightly.
- 3. The redistricting board has issued a draft map that moves Unalaska back into the district with Bristol Bay following the Supreme Court's decision on the Voting Rights Act.
