CANVASSING COMMITTEE

A total of 26 absentee ballots were cast, one of which was a questioned ballot. There were 13 questioned ballots cast at the polls on Election Day, bringing the total number of questioned ballots to 14. None of the questioned ballots were counted. The breakdown of questioned ballots is as follows:

- Three were not registered to vote in the State of Alaska
- Two were registered to vote in Anchorage
- One was registered to vote in Adak
- One was registered to vote in Cordova
- Seven were not registered until after the deadline for this election had passed

On Election Day there were 1779 voters on the precinct register in Unalaska. The total number of votes cast by qualified voters was 440, which is a 25% voter turnout.

The Canvassing Committee recommends certification of the election.
