**CANVASSING COMMITTEE**

A total of 79 absentee ballots were cast, one of which was questioned. There were 11 questioned ballots cast at the polls on Election Day. One of the questioned ballots was determined to be valid and was counted. Of the 11 questioned ballots that were not counted:

- 3 registered after the deadline for this election
- 2 were registered in a different district/precinct in Alaska
- 6 were not registered

On the day of the run-off election there were 1969 voters on the precinct register for Unalaska. The total number of votes cast by qualified voters was 614, which is a 31% voter turnout.

The Canvassing Committee recommends certification of the election.
