THE USE OF REVENUE FROM THE 1% SALES TAX SPECIAL REVENUE FUND, NOT TO EXCEED \$1,300,000 ANNUALLY, TO SUPPLEMENT THE ANNUAL WATER, WASTEWATER, AND SOLID WASTE PROPRIETARY FUNDS BUDGETS.
