My name is Jason Gates and I was born in Missouri and moved to Tennessee when I was eleven. I came to Alaska in 1989 at the age of 14 to help my sister transition through a divorce. At 15 I moved out on my own, worked various positions at Safeway all the while staying in school and Graduated from East Anchorage High School at 17. Aviation was my love and I became a licensed A&P mechanic at 18. This career field took me to Washington, Hawaii, and back to Alaska. I started work for Pen Air in 2000 and in 2004 a mechanic position opened up in Unalaska. Working in Utilities definitely helps one understand how a City is designed, built and the infrastructure that it takes to keep the city running. In 2009-2010 my wife and I owned a house in Wasilla, she was a stay at home mother while I continued to travel to Unalaska for Pen Air. I have called Unalaska my permanent home since 2010 when my daughter was born and we moved back as a family. We decided to sell our Wasilla home in 2013 and in January 2014 we purchased our home in Unalaska. I love Unalaska and have a desire to serve in a capacity that would help shape the future of this city.

<u>SUMMARY</u>: Seat CC-B was declared vacant effective December 13, 2019 following the resignation of Council Member James Fitch. Council must appoint a qualified person fill the vacancy within 30 days. Adoption of Resolution 2020-01 will accomplish this requirement.

PREVIOUS COUNCIL ACTION: Council accepted Mr. Fitch's resignation on November 26, 2019 with Resolution 2019-60 and declared Seat CC-B vacant effective December 13, 2019. Council also directed the City Manager to advertise the vacancy, accept letters of interest and to invite such interested persons to tonight's meeting. Council's directive was accomplished.

BACKGROUND and DISCUSSION: Vacancies on council are filled, pursuant to UCO 2.12.050(C), by the remaining council members, within 30 days of vacancy, appointing a qualified person to fill the vacancy. The appointed person will serve until the following year's regular election in October 2020. Coincidentally, the regular term for Seat B expires in October 2020. The qualifications for a person appointed to fill a vacancy are the same as qualifications for anyone who wants to declare candidacy for council: they must be a voter registered in the city who has resided in the city for no less than twelve consecutive months immediately prior to the time of submission of declaration of candidacy.

Letters of interest were submitted by the following individuals:

- 1. Jason Gates. The City Clerk has confirmed that Mr. Gates meets the eligibility requirements.
- 2. Thomas D. Bell. The City Clerk has confirmed that Mr. Bell meets the eligibility requirements.
- 3. Greg Peters. The City Clerk has confirmed that Mr. Peters meets the eligibility requirements.

Mr. Bell is a member of the Planning Commission. Pursuant to UCO § 8.04.060(C)(5), no member of the City Council may serve concurrently as a member to the City of Unalaska Planning Commission and Platting Board. If Mr. Bell is appointed to Council, his membership on the Planning Commission is immediately forfeited.

Mr. Gates is a member of the Parks, Culture & Recreation (PCR) Committee, which is an advisory committee relating to the improvement, operation and maintenance of the City's PCR facilities and programs. There is no prohibition in code against serving concurrently on the City Council and the PCR Committee.
