On March 18th, 2020, the Airport Restaurant was one of the few businesses in the city of Unalaska ordered to shutdown. Although, Airport Restaurant was still permitted to do take-out orders, the volume of sales dropped dramatically. Since reopening, business has been not been up to par and on a daily basis, the breakeven point is often not reached. With limited foot traffic from the airline shut-down, as well as fisherman and transient workers hunkering down, business will be affected for the unforeseeable future. State and local mandates caused us to stop all massage therapy from 3/25 to 5/4, offer chiropractic to severe pain patients only, and physical therapy via telemedicine. This allowed local clinics to be able to focus on those patients that were sick and preparing to treat COVID positive patients. The community was also under a stay at home order during most of April further limiting the ability to come for treatment as many stayed home as long as they could until the pain got too bad then came in, this caused a loss of \$15k from March-May. The massage therapists due to these mandates were forced to seek unemployment as they were unable to practice until their licensing board allowed them back to work 4/20 for severe pain patients and 5/4 for all patients.
