IFHS has experienced a significant decrease in patient revenues over the past three months as a result of COVID-19 (\$444,254). Though our volumes have been increasing, much of it is related to lower revenue COVID testing visits. One of our biggest challenges at this point is planning for our capital equipment and building updates. We are requesting funding for additional life saving/sustaining equipment and for equipment that increases our team's safety as we care for patients with infectious diseases in the amount of \$74,870 including a Zoll X-Series ECG/Debrillator, Lucas Chest Compression System, Optiflow Nasal Cannula Device, Wall Suction, and a Negative Pressure Unit and Installation (list with estimated prices have been provided to the City of Unalaska). Additional funds to support ongoing operational expenses would also be very helpful in this time. Our needs are not as immediate as some and can hold until the second round of awards if needed.

The Museum of the Aleutians (MOTA) has been impacted financially by COVID-19 due to the forced closure on March 16th, 2020, at which time we suspended our operations, with the exception of virtual programs. MOTA lost revenue from admissions, daily sales, memberships, events, and gaming revenue. We see the majority of our admission and store sales between May and September from the increase in tourist visitation arriving on cruise ships and the ferry. Based on the cruise ships that were coming to Unalaska this year, bringing 7030 passengers to our island, we could have made \$49,210 in admissions alone, although not all of them would have visited MOTA. These passengers would have contributed to our store sales and purchased special tours, as well. Combined with loss from other tourists, daily sales, memberships, and gaming, I estimate lost revenue to range anywhere from \$40,000 to up to \$130,000. MOTA's incurred expenses related to COVID-19 are \$1763 in supplies and Optimera Cards.
