- b. Tobacco Excise Tax City Clerk, Marjie Veeder

City Clerk presented a summary and background information on this issue. Staff requested Council direction on the proposed ordinance imposing an excise tax on tobacco, rate of levy, fund dedication options and whether to proceed with an increased sales tax levy on alcohol and marijuana.

d. Site selection, new Public Safety facility – Thomas Cohenour, DPW Director with Corey Wall of JYW Architects and Jay King, Police Chief

Corey Wall, JYW Architects, led the discussion on the conceptual design executive summary and reviewed analysis of alternate sites to house either a new DPS department with both Police and Fire Departments or a stand-alone new Police Department and utilize the existing building for the Fire Department.
